Project #1: Remove and Replace – Anahim Flats

- Fence Line Removal and Replacement of approximately **3,720** meters of Four Strand Barbed Wire Fence.
- Area located just above the Mill site at the top of Lee's Hill

Project #2: Remove – Anahim Flats

- Fence Line Removal of approximately **2,358** meters of Four Strand Barbed Wire Fence.

Project #3: Remove and Replace – Henri Lake
